FROM AN AMERICAN PERSPECTIVE

It's easy to criticize how things are done in America when one lives in Europe. Below are a few reasons or explanations behind some of these bizarre differences.

1. The larger drinks at McDonalds in America may have something to do with our obsession with ice in drinks. It's not uncommon for a cup like this to be filled completely with ice before any soda is added. I would guess there is about the same amount of actual soda in both examples. We like things cold.

- 2. Why are some ingredients banned in Europe but not in the US? There are two main reasons. Firstly, in 1958 Congress amended the Food, Drug and Cosmetic Act to ban potentially carcinogenic food additives from gaining FDA approval. However, some additives that were used before the Delaney amendment's passage are considered to have prior approval.¹ Secondly, the FDA does conduct studies on potentially harmful food additives, but their European counterparts have stricter limits.
- 3. Under the Family and Medical Leave Act of 1993 American workers are protected for 12 weeks unpaid by law². There is no mandated paid leave. However, many companies offer paid parental leave as part of their employee benefits package. Families must weigh these benefits before accepting a job offer. The theory is that it creates competition amongst employers for the best workers. Some companies offer as good as or better parental leave packages than many European countries.
- 4. There are a lot of reasons why college in America is so expensive. Here is a list of just a few: highly paid skilled workers at both public and private universities, many students *go away* to college rather than staying at home while they complete their studies, the facilities at American colleges are different, such as dormitories and student life facilities, lower state taxes means more take home pay but less public investment in the public university system, American universities attract full-paying foreign students, etc.³
- 5. Good healthcare in America is not impossible to find. Typically it is linked to the company you work for. Companies offer varying levels of health insurance in order to compete for the best employees. There are two wings of the American healthcare system that take care of certain patients through the government, much the same way Europeans enjoy their public healthcare systems. Medicaid is healthcare for the elderly (65 and older) and disabled, while Medicare deals with low income patients.
- 6. Guns, and especially handguns are an American pastime. Not everyone has gun fever, though. About 53% of Americans favor stricter gun laws. It's hard to explain, but it's cemented in the American psyche as an unalienable human right to own and operate a firearm.
